4.7 Notes for the doctor:

If decomposition products are inhaled the following symptoms can occur:

Unconsciousness, Impaired consciousness, Cyanosis (blue coloured blood), Vomiting, Cardiac arrhythmias, Headache, Spasms, Circulatory collapse, Dizziness, Impairment of vision, Nausea

Treatment:

Supervise the blood circulation. Regulation of the blood circulation, possible shock treatment.

Where appropriate artificial ventilation.

In the case of bluish discoloration (lips, earlobes, finger nails) give oxygen as soon as possible.

In the case of lung irritation: Primary treatment by using Corticoid spray, e.g. Auxilison spray, Pulmicort-dosage-spray (Auxilison and Pulmicort are registered trademarks).

5.1 Suitable extinguishing media: Water and extinguishing powder from safe distance at fire in the surroundings.
